STUDENT FEE WAIVER

- Evidence indicating qualification that the student is currently receiving aid under Article IV of the Illinois Public Aid Code {Aid to Families with Dependent Care (AFDC)/Temporary Assistance for Needy Families (TANF)}
- Evidence indicating student qualification for the upcoming 16-17 school year for Free or Reduced Lunch pursuant to Illinois Rev. Stat. Ch. 12 Para. 712.1 et. seq.
- Signed statement that the household gross income is at or below the levels shown on attached chart. (These levels can change yearly.)
- If the number of household does not agree with dependents listed on the Income Tax Return, the applicant must provide legal documentation to support current and correct number in household.
