

STATE OF ILLINOIS SCHOOL ENTRANCE MEDICAL REQUIREMENTS 2014-2015

A. NEW SCHOOL PHYSICAL EXAMINATION – Kindergarten, 6th, 9th, & Out-of-state students only

A school physical exam must be performed by a physician in the state of Illinois, recorded on the *Certificate of Child Health Examination* form (obtained from your doctor.)

Sports physicals do not count as a school physical Due Date: October 15, 2014

B. EYE EXAMINATION – Kindergarten & Out-of-state students only

An eye exam performed by an Optometrist or Ophthalmologist and recorded on the state *Eye Examination Report* is required. If an eye exam is not attainable then an *Eye Exam Waiver* (found within the on-line registration or on the district website) is required. Due Date: October 15, 2014

C. UP-TO-DATE IMMUNIZATIONS AND TESTS – All Grade Levels

Deadline for Immunizations - October 15, 2014

DTP or DTaP (Diphtheria, Tetanus and Pertussis) K – 12 th	4 or more doses, with the last booster dose given after 4 years of age
Tdap (Tetanus and Pertussis) 6 th – 12 th	1 dose that must be dated after May of 2005. The DTP, DTaP, DT or Td immunizations are not the same vaccine as the Tdap and do not count as the Tdap requirement.
OPV or IPV (Polio) K-12 th	3 or more doses, with the last booster dose given after 4 years of age
MMR, K – 12 th	2 doses of live Measles, Mumps, Rubella virus vaccine
Hepatitis B, 6 th – 12 th	3 doses of live Hepatitis B virus vaccine
Lead Screening, K only	1 screening for lead poisoning is required prior to admission to Kindergarten only.
New for 2014-2015 Varicella* (Chickenpox) K, 6 th and 9 th only	2 doses of the Chickenpox vaccine is now required for Kindergarten, 6 th and 9 th graders. New for 2014-2015
Varicella* (Chickenpox) K – 12 th	1 dose of the Varicella vaccine is required for all grade levels. *If the child has had the Chickenpox then reporting the year the child had the disease is required
Proposed for 2015-2016 Meningococcal Conjugate Vaccine MCV4 (Meningitis / Sepsis)	1 dose of MCV4 for 6 th graders and 2 doses for 12 th graders. This will apply next school year to grades 6 th and 12 th only. Proposed for 2015-2016

D. DENTAL EXAMINATION – Kindergarten, 2nd and 6th grades only

A dental exam performed by an Illinois dentist dated between January 1, 2014 and May 15, 2015 is required. If a dental exam is not attainable then a *Dental Exam Waiver* (found within the on-line registration or on the district website) is required. Due Date: May 15, 2015.

E. NECESSARY MEDICATIONS - All Grade Levels

A *Medication Consent Form* must be completed by your doctor and on file, if your child is to receive necessary medications at school. A *Student Self-Administration of Asthma Medication Consent Form* must be completed by your doctor and on file if your child is to self-administer asthma medication at school.
