Digital LED Sign Display 4ft. x 8ft. Viewing Area 10mm Pixel

Description of the project shall include but is not limited to: Installation of new sign; sign, light box, graphics, materials and parts, installation, power and data connections, and removal of the existing sign. The contract time is 90 consecutive calendar days.

Estimated construction cost: \$22,000-\$48,000

Bids will be accepted until 12:00 p.m. on September 30, 2022 at which time all received bids will be opened read by the Board Representative. All bids shall be made, presented, and delivered only to **Herscher High School c/o: Brad Elliot, Principal, 501 N Main St Herscher, IL 60941**. All proposals must be clearly labeled on the front of the packet as 'HHS Digital Sign Bid Proposal.' Bids are to remain firm for a period of 60 days after the bid due date.

The lowest bid shall be the lowest bid price on the base contract without consideration of the prices on the additive or deductive items. The selections process selected does not preclude the District from using any of the additive or deductive alternates from the contract after the lowest responsible responsive bidder has been determined.

Bid documents for this project will be available on or after August 30, 2022, in person at Herscher High School, on the District website hcusd2.org, and/or via email request to <u>elliotb@hcusd2.org</u>.

Each bidder shall be a licensed contractor and be licensed to perform the work called for in the contract documents. Subcontractors shall be licensed pursuant to Illinois law for the trades to perform the work called for the documents.

The contractor and subcontractors shall comply with the requirements set forth by the labor code; general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in the locality in which this work is to be performed for each craft, classification, or type of worker needed to execute this contract. It shall be mandatory upon the contractor to whom the contract is awarded, and upon any subcontractor under such contractor, to pay not less than the said specified rates to all workers employed by them in the execution of the contract.

The District reserves the right to reject any/all bids or to waive any irregularities or informalities in any bids or the bidding.

No bidder may withdraw any bid for a period of sixty days after the date set for the opening bids.

It is each bidder's sole responsibility to ensure its bid is timely delivered and received at the location designated as specified above. Any bid received at the designated location after the scheduled closing time for receipt of bids shall be returned to the bidder unopened.
